PHARMACOLOGICAL ACTION

Boldocynara is a herbal medicine product against dyspepsia and for stimulation of gall secretion, composed of the four tinctures Taraxacum off, radix cum herba rec. T. 1:17, 45 %, Cynara folium rec. T. 1:30, 45%. Peumus boldus, folium sicc, T. 1:10. 70 % and Mentha piperita, herba rec. T. 1:18,3 %. Each of these tinctures is acknowledged for the treatment of upper abdominal complaints by the German commission E monographs: Taraxacum, Cynara and Boldo for dyspeptic ailments and Mentha like Boldo for spasmodic complaints of the gastro intestinal tract and gallbladder ducts. The application field for Boldocynara is the accredited actions of its constituents, i.e. A choleretic effect for four tinctures and additionally for Boldo and Mentha antispasmodic and carminative activity respectively.

INDICATIONS

Assists in supporting the functions of the liver, stimulate bile production and therefore assist in the symptomatic relief of digestive disturbances.

CONTRA-INDICATIONS
